Gearing up to go green

Decoding The Electric Vehicle Roadmap In India One Path At A Time

Gouri Srivastava & Varada Kachroo, IX B **AIS VKC Lko**

s a means to fast track a switch to zero emission electric vehicles and subsequently rein in on humanity's ecological footprint, the European Union, in July 2021, proposed an effective ban on the sale of fossil-fuel driven vehicles as of 2035. As its ripple effect, the Indian motor industry, already keen to espouse a 360degree approach to transmute India into an EV nation, envisaged to make nearly two-third of new vehicles (including 70%) two-wheelers, 30% cars, and 15% lorries) on the country's roads electric by the end of 2030 (COP26 climate summit, Glasgow). Though highly recommendable, the efficaciousness of this breakneck green automotive transition in India is, howbeit, subject to debate. So, ride along as we tap into the potential of this broadly untapped domain

Mapping the path undertaken

For the uninitiated, electric vehicles operate on traction motors or electric motors that use rechargeable batteries for propulsion, instead of an internal combustion engine that uses fuels like

powered by solar panels, onboard battery packs (BEVs), or by a mix of batteries and internal combustion (PHEVs and HEVs). Hyundai Kona Electric, Mahindra e2o, Tata Tigor EV 2019, Porsche Taycan, Tesla, etc., are some of the recent fourwheeled contributions made by the automotive sector worldwide. Besides, as per the International Energy Agency, there were about 11 million such registered electric vehicles on the road at the end of 2020, the numbers for which are set to soar to somewhere between 145-230 million by the end of the decade, depending on how bold our global emission reduction targets are. But this revolution in the mobility sector is not something novel; these vehicles first came into being in 1880 when tributable to air pollution from William Morrison, a chemist exhaust emissions (Internafrom Iowa, US, helped construct

petrol or diesel. These can be a six-seater electric car. Analysing the amenities offered

In the Indian context, electric vehicles can be a promising prospect for sundry reasons... To stave off climate change: India has the "distinction" of being home to 22 of the world's 30 most polluted cities, with vehicular fumes as a significant

contributing factor. An estimated 74,000 deaths in the country in 2015 were solely attional Council of Clean

Transportation). Besides, as

Germanwatch, our nation is the 7th worst-hit terrain in the Global Climate Risk Index 2021. Thus, in order to meet its goal of reducing GHG emissions intensity by 33-35% from 2005 levels, and to further become carbon neutral by 2070, a shift to EV is mandatory.

To reduce energy dependency: About 80% of India's transport fuel is imported from countries abroad. And so, according to the Council on Energy, Environment and Water (CEEW), the nation can save crude oil imports worth an estimated 1 trillion INR if EVs managed to procure even 30% share of its new vehicle sales by 2030.

To improve job opportunities: Though a switch to EVs would significantly reduce jobs in both the oil sector and the ICE ve-

> hicle manufacturing sector, it would increase the market share of powertrain, public chargers,

> > and battery to

additional 120,000 new jobs in the sector. Job opportunities in associated areas such as telematics, battery, recycling, etc., would surge too.

To lower running costs: With the price of petrol hitting 100 INR per litre in almost all the Indian cities today, the cost of running a petrol/diesel-based vehicle amounts to about 8-9 INR per kilometre. Conversely, the fuel cost of an EV is only 80 paisa per kilometre and that of charging one with an average battery is approximately 75 INR per day. With about 75-80% fewer moving components than fuel cars, their maintenance bill is negligible too.

To provide better performance: With a cutting-edge battery technology, EVs are lighter than the traditional cars, so their acceleration capacity is tremendous. For instance, Tesla Model S is one of the fastest accelerating cars in the market, going 0 to 60mph in just 2.5 seconds. To compound this, owing to a lack of large engines, these are more spacious - a perfect fit for the Indian joint families.

Nation first, always first An Ex-Soldier's Journey From Fighting On The Border To Serving People Within

> > he welfare of my people always comes first," says Dr BD Mishra. With an illustrious army career spanning over three decades, Dr Mishra, a retired brigadier and the former commander of National Security Guard (NSG), is currently serving as the Governor of the state of Arunachal Pradesh, having taken the oath in 2017. His passion to serve the nation is reflected in his endeavours towards ensuring a democratic, par-

and all-inclusive form of governance in his state. In his conversation with the GT reporters, he shares his riveting journey from being a soldier to finally becoming a statesman. We provide you excerpts of the same.

As an Indian army personnel

As an integral part of one of the most disciplined armed forces in the world, serving in the Indian Army was an earthshaking experience for me. I set off as a cadet in Kohima team and was then commissioned in Infantry, the Madras Regiment, in 1961; thenceforth, I fought for the defence of the nation in the 1962 Indo-China war, the 1965 liberation war, and the 1971 Indo-Pak war, before finally becoming a Brigadier. Post my retirement in 1995, having served in the army for almost 33 years, I volunteered in the 1999 Kargil War as well. For I am a soldier and I need to protect my country and my people till my last breath.

As the NSG Force Commando

The 1993 Indian Airlines Flight 427 Hijack is one event that marks my career as the commander of NSG. The hijack was executed by a member of the terrorist organi-

sation Hijbul Mujahideen. And I still remember how the then Prime Minister was, quite understandably, worried about the safety of the civilians onboard, and how I had to assure him of the mission's success to get a clearance. Having carefully examined the airfield post that, we stormed the aircraft and executed the hijacker without any civilian casualty, rescuing all the 126 passengers, 9 infants, and 6 crew members safely at the Raja Sansi Airfield, Amritsar.

As the governor of AR

Arunachal Pradesh is the Nippon of India. The state comprises about 26 major tribes and 100 minor ones, each with its distinct cultural identity, tradition, and ethos. It is a mosaic of people, serving as an example of perfect harmony in diversity for the rest of the nation. But in spite of being so culturally rich, the state never fully received the attention and developments it sought. However, owing to the dedicated efforts of PM Narendra Modi, and our CM Pema Khandu, things are really catching up. With necessary technological and infrastructural advancements, including rural electrification, better roads, appropriate water supply, and other border area development projects, etc., to name a few, our state government is leaving no stone unturned to make Arunachal Pradesh one of the best states of North Eastern India. And I think sooner or later, we'll achieve that goal for sure.

Stop acid attacks

Sheroes Café – Where Acid Attack Survivors Get A Whole New Lease Of Life

Trigger Warning: Violence *splash*

As seconds passed, agonised screams of a woman engulfed the streets as she struggled to pacify the blazing fire on her face. She scratched, scraped, and screeched as hard as she could, but the end to her suffering was nowhere in sight. A few months later, she found herself in the emergency ward, with her aggrieved parents by her side. "Our life's over," they said. Baffled, she questioned "Why?" till she saw, with what was left of her eyesight, her disfigured face in the mirror nearby. It wasn't her face; it wasn't the body she remembered, yet it was her life that ended! But did it really? Alok Dixit, co-founder of the Sheroes Hangout Café, says no! For "there is nothing stronger than a broken woman who rebuilds herself," he tacked on.

The idea

Nestled amongst a row of busy shopfronts in Lucknow is a café named Sheroes, housed and run by women who have survived acid attacks and are now on a course to redefine their lives. "Many women survivors led solitary lives prior to working at the café. They were ostracised and left to struggle with feelings of shame and trauma. Hence, it became necessary to wipe out those scars from their subconsciousness. Sheroes does exactly that by aiding them at the earliest,



and by treating them as fighters rather In 2014 thus, he inaugurated an organithan victims," asserted Alok.

The inception

"Being appalled by the staggering figures of acid attacks in India coupled with a complete lack of awareness about the issue, I started the campaign #StopAcidAttacks way back in 2013. But somewhere along the road, I realised that the survivors of these brutal attacks required more immediate attention. For most of them faced unemployment and were forced to rely on their families that were already exhausted by the burden of their medical expenses. This is when I resolved to turn my campaign into something more concrete," summarised Alok.

sation, namely the Chhanv Foundation, for the rehabilitation of these women. Upon further realising that many of them lacked the necessary professional skills, he laid the foundation stone for Sheroes, where both skilled and unskilled women work and earn together. Its first branch, entirely based on crowd funding, was set up in Agra in 2016. This was followed by a second café in Lucknow.

The execution

With stories of the survivors' horrific ordeal inscribed on its walls, Sheroes not only works towards the empowerment of women, but also materialises it in the form of an eatery, an information hub, an

activism workshop, a one-point centre, and a help desk for the victims of violence. "Guests can avail these facilities, all while learning about acid attacks and meeting the strong, resilient women who endured them. One would find Farah at the counter; she was attacked by her husband in 2019. Shanti, who was attacked by a distant relative over some familial dispute, can be found serving the orders, and Rani, who was 17 when she was attacked by a random suitor, managing the helpdesk," detailed Alok.

The reception

Sheroes was honoured with the Nari Shakti Puruskaar in 2016 by the then President of India, Late Pranab Mukherjee. It has also been acknowledged by numerous global organisations such as the German Best of Business Awards, as its reach extends far beyond the country's borders. However, the journey to empowerment wasn't always smooth or as Alok puts it, "In 2018, we received a notice from UP Mahila Kalyan Nigam to vacate the café, citing its inability to fulfil its 'purpose' as one of the reasons". However, the general public extended their support to the café, and protests were held to express solidarity with the survivors. As the matter reached the Allahabad court thus, orders were issued to revoke the notice. This is how a café

State of emergency declared A state of emergency has been

Fresh skirmishes between Armenia and Azerbaijan broke out on Nov 16, killing 7 Azerbaijani service members and wounding another 10. Armenia has also reported 1 casualty, with 13 soldiers captured and 24 missing in action. After the violent exchange of hostilities, both sides are currently under a Russian-brokered ceasefire with the additional deployment of 2,000 peacekeepers into the hostile region. The clashes marked the worst fighting between the two nations since the six-week long war last year.





Diego y Yo sets a record

Diego y Yo, the self-portrait of the Mexican artist Frida Kahlo, featuring her husband Diego Rivera, was sold at an auction at Sotheby's in New York for 34.9 million USD, setting the record for the highest price ever paid for a painting by a Latin American artist. Bought by an unidentified buyer, Diego y Yo (Diego and I) was completed in 1949, and is one of Frida's most revered paintings, depicting a tearyeyed Kahlo with Rivera on her brow, who has a third eye embedded on his forehead.

Defence equipment for army

As a major push towards the

agenda of 'Aatmanirbhar Bharat', PM Modi, on Nov 19, handed over indigenously designed and built equipment of defence to the three chiefs of armed forces in UP. Flashback: April 4, 1973 (Inauguration Day)

"Triumph of human inventiveness, that's how they are expounding our execution, yours and mine!" "High Five! Besides, for Governor Rockefeller, we are "a dream come true". Imagine, twinnie!" "Twinnie? We ain't no twins. You are a duplicate, 2 WTC. The men behind our inception, Winthrop W. Aldrich and Mr David Rockefeller, never intended for us to be two. The original 1959 plan was to build a single 7 storey office, and before you start won-

dering, that's me!" "But that proposal was soon scrapped, 1 WTC. We are both 110-storey-high with 4,300,000 sq ft of floor area each, as per our architect Minoru Yamasaki's design draft. Talk about being equal!"

"What about being a year late? Though our construction began in February 1967, they effectuated me in 1972, while you started accommodating tenants way after in 1973."

"Pfft! There's no winning you! But just so you know, a little modesty goes a long way."

"Stop with the lecture, will you? I mean just look at us! Two giant tubes composed of more than 200,000 pieces of steel from across the country, 425,000 cubic yards of concrete, 40,000 doors, 43,600 windows, and 6 acres of marble – all of that coupled with the labour of over 10,000 workers, making us the world's tallest structures. We are the dream!"

"Tallest? What about the probability of some airliner bumping into us someday, as Lawrence Wein claimed back in 1968?"

"Na! He is just jealous because we surpassed his 1,250-foot-high Empire State Building. Plus, criticism comes to those who stand out. So, relax!" "I wonder if you really are my biological twin!" "Because I am not. Surprise! Surprise!" **That phase between birth and death we call life** While our title of being the tallest in the world didn't last long (not even a year), for Chicago's Sears Tower overshadowed us with its 1450-foot-high frame in 1973, but we were functioning just fine, with a revenue of over 204 mln USD by 1983. We had our own fair share of challenges though. The sudden bombing of 1 WTC on Feb 26, 1993, the attack that claimed 6 lives with damages amounting to over 600 mln USD, was spine-chilling. We had to go through several bouts of renovations to overcome it. In other developments, we were leased to a private developer, Larry Silverstein, in July 2001, just 2 months before the unthinkable occurred...

Flashback: September 11, 2001 (The D-Day) 8:46 am

"2 WTC, why do I see an airliner coming straight at..." *screams* (An American Airlines Flight 11 crashed into 1 WTC, ripping a hole from its 93rd to 99th floor.) "No! What just happened? Help! Somebody help my brother." 9:03 am

"I guess it's my turn now..." (A hijacked United Airlines Flight 175 slammed into 2 WTC, igniting a fireball and gashing it from 77th to 85th floor.) 9:59 am

"I quit, 1 WT…"

(Fire weakened the steel trusses of 2 WTC; it collapsed, having burnt for about 56 minutes.) 10:28 am

"I am coming, twin!" (1 WTC collapsed, too.) The fall of the most prized icon of American ingenuity thus claimed a total of 2,753 lives in what is considered to be the deadliest terrorist attack in human history; the abutting buildings too succumbed to the fire and falling debris. It took over 8 months of rigorous clean-up for the site to be recovered. However, more than 20,000 people were rescued, thanks to the city's emergency department personnel. In 2006, construction for the new Word Trade Complex began afresh, only this time it wasn't the original Twin Towers but one skyscraper, namely 1 WTC, that made a comeback (in 2014); the project also included the

Insuring nature... ... To Conserve It And Further Ensure Climate Resilience

lanketing less than 1% of the earth's surface yet insulating and catering for over 4000 species of marine life, and providing livelihood to about 840 million humans, coral reefs are presently faced with the menace of extirpation. Going by the recent reports, a draconian 30-50% decline has been recorded in the coral reef coverage worldwide since 1980s. Why and wherefore? Natural storms coupled with human actions numbering marine pollution, habitat destruction, overfishing, climate change, and the consequent bleaching, acidification, disease upsurge, and recrudescence.

Subsequently enervated, the global coral reef crisis stipulates swift attention and action. It should be acknowledged that nowhere does this distress call suggest that the coral reefs are incapable of withstanding the storms on their own, for they have been at the coalface since

millions of years. Additionally, a healthy coral reef alone has the capacity to truncate a comber's energy by a staggering 97% before it wallops the shore, diminishing both the storm and the erosion that accompanies. However, the additional strain of human opportunism renders its efforts futile. And paradoxically, it is human mediation that it quests for. So, here's looking at the efforts made in this respect... Stratagem I: An initiative of the Mexican Quintana Roo government in collaboration with The Nature Conservancy and The National Parks Commission, Reef Brigades - a response team of trained people to repair the reefs post a storm - were formed

in 2018. When, following a storm, the broken corals roll around and get buried in the sand, these human brigades, with timely intervention, protect the corals by fastening them back onto the reef. Predominantly impacting the Yucatan Peninsula, the 2020 hurricane season with its record 27 storms, however, proved to be catastrophic, leaving the corals devastated every time before they could be fully recovered. Notwithstanding which, continuous toiling by the said brigades helped in stabilising and replanting numerous coral colonies. Stratagem II: Coastal Zone Management Trust, set up by the Quintana Roo government, purchased the

first ever coral reef insurance policy in 2019. The policy assures adequate funding for the repair work of these ecosystems post a Category 3 storm, one with a wind speed of 100 knots or greater. The insurance was soon encashed when Hurricane Delta slammed the coast in October 2020, providing around 800,000 USD for restoration purposes. Howbeit, its potential could not be properly realised then owing to the pandemic-induced constraints.

The essential question, therefore, boils down to the effectiveness of such measures. Would the early response and funding system prove to be a win for all, the coastal community, nature, and the insurance industry combined, or would it commodify nature further, adding to the tribulations of the already distraught coastal belt, is what remains to be seen.

Understanding the challenges With 236,802 units sold in the first half of 2021 alone, the demand for EVs in India is increasing. However, the infrastructural requirements for the same fall short for reasons aplenty... Lack of charging stations: Though well-equipped in the manufacturing of ICE vehicles, with as many as 70,000 fuel stations across the country, India currently has only 427 public charging stations for EVs; this while the batteries need to be charged every 200-250 kms. Additionally, as per the recent estimates, over 80% of the charging takes place at the owner's residence or workplace, which in itself is a great fallout if done through electricity generated from thermal plants run on coal. Besides, private light-duty chargers are slow and require upto 8-12 hours for a full charge, forcing feasibility out. *Lack of production capacity:* India lags behind in the production of several gears such as batteries, controllers, semiconductors, etc., necessary for the manufacturing of EVs in the nation. Since reserves of lithium, cobalt, and nickel are concentrated in a few countries like China, Congo, etc., India has to import lithium-ion cells and batteries in large quantities to satisfy its energy needs. If projections are anything to go by, the domestic EV market would require a minimum of 10 GW of Li-ion cells by 2022, about 60 GW by 2025, and over 120 GW by 2030 to meet its set goal; where the nation barely manages to add about 20 GW every year to its grid for all its energy needs combined. Thus, to provide such large outputs of energy for EVs alone is tough. Lack of recycling facilities: India manages to recycle only 5% of the spent Liion batteries, a lacuna in the nation's technical skills to achieve the same if we may. Plus, dumping them is not an effective solution either, for they contain toxic, flammable materials that cannot be left untreated. But since EV batteries would account for over 80% market share in the Li-ion battery market by 2030, the government needs to come up with a well-defined policy for their eco-friendly end-of-life handling. Lack of battery life: The battery life of an EV ranges from 6-8 years, requiring replacement when its capacity falls below 80%. These frequent replacements are to be borne by the users, and since the cost of battery amounts to about 50% of the vehicle's purchase price, it becomes a financial burden. Lack of a skilled workforce: Though our mobility sector is filled with talented people, these lack the niche skills required to work in the EV sector, and so do more than a third of our nation's engineering students. Besides, as projected, India would need 15,000 engineers a year for designing and servicing EVs from 2022 onwards, so changes in the curriculum are imperative.

ationalising mass transition to EVs in a nation of over 1.3 billion people is by no means an easy feat to attain. However, in a bid to phase out all the ambiguity surrounding this vehicle of the future and to further drive its manufacturing and adoption in the country, the Government of India has been gunning hard year on year. Along with the introduction of initiatives such as the National Electric Mobility Mission Plan (NEMMP) 2013, and FAME India 2015, it has also proffered several financial incentives, including a 1.5 lakh INR tax exemption on loans to purchase EVs, fixating GST on EVs at 5% versus 28% for ICEs, customs duty exemption on their specific parts such as the electric drive assembly, onboard charger, e-compressor, etc., amongst others to cut down costs. At the state level, many fiscal and non-fiscal incentives are being made available for the production of chargers and charging stations. In one such instance, the government of Telangana amended their building by-laws to accommodate around 600 charging stations across the state. However, all this will come to naught if enhanced industry cooperation, both public and private, fails to accompany it; a higher consumer awareness would be equally welcomed!

The depty trap

China's debt trap

C here are two ways to conquer and enslave a *country - one is by the* sword; the other is by debt," said John Adams, an American statesman. Given how things are panning across the globe, with China in the lead, his words hold more water in the present times. The news – China is using its Belt and Road initiative as a debt trap *diplomacy technique, at least that is* what media and trade analysts across the world have to say. Here's treading over conjecture, facts, and analysis to find the truth that lies somewhere in the grey.

What's this about?

Debt-trap diplomacy is a situation where an economically powerful country lends money to a borrowing country, which increases the lender's power and leverage over the borrower.

Through debt-trap diplomacy, the creditor country aims to increase the loan on the debtor country, putting them in a vulnerable position, and extracting political, economical, or any other kinds of favours in return when the debtor country is unable to pay the amount back. Today China is known as the

world's biggest official creditor

as its international loan has surpassed more than 5% of the entire world's GDP. It has even left behind other international staple lenders like the World Bank, the International Monetary Fund, and all the nations under Organisation for Economic Cooperation and Development.

The countries most in debt to China are Pakistan, Indonesia, Vietnam, Laos, Sri Lanka, Bangladesh, Malaysia, Myanmar, Cambodia etc. China has been lending money under its Belt and Road Initiative.

Wait, wait...what is this **Belt and Road Initiative?**

■ The Belt and Road Initiative (BRI), also known as One Belt One Road, is a global infrastructure development programme that was started by the People's Republic of China in 2013.

The plan for the programme was that the Chinese government will invest in nearly 70 countries and other international organisations for their infrastructural growth, and will create investments like ports, skyscrapers, railroads, roads, airports, dams, coalfired power stations, and railroad tunnels in the debtor countries.

The initiative aims to help China to "assume a greater leadership role for global affairs in accordance with its rising power and status". It was incorporated into the Constitution of China in 2017 and has been assigned a target completion date of 2049.

■ In a study conducted by CEBR, a global economic consultant company, it was forecasted that BRI will likely boost the world's GDP by 7.1 trillion USD per annum by 2040.

How China is taking advantage of this?

mal body of donor countries that intervenes if a country has trouble paying debts. This ensures that China gets its due in the way it wants.

A lot of these contracts give Chinese state banks priority, and have clauses that will give China "great leeway to accelerate repay-

ment." They also mention that any severance of the diplomatic relationship can be classified as a breach of contract, requiring the debtor government to repay China the loan immediately.

■ 30% of these BRI contracts require debtor countries to deposit collateral in special escrow accounts which are often held by Chinese banks, which can be seized in the event of bankruptcy.

In many contracts, future exports of raw material is being used as collateral in the event of the inability to repay.

If it will help the world's GDP, why is everyone calling China a loan shark?

AidData, a research lab, tracked over 13,000 BRI projects worth 843 billion USD across 165 countries and found out that these projects actually have 385 billion USD in "hidden" debt, which means that these debtor countries actually owe more money to China than they think. The loans have been structured in a way that some parts of it are hidden from the World Bank, because rather than lending them to government institutions, a part of the amount has been given to private firms. By influencing these private firms, China can influence market dynamics in these countries.

This has caused the debt exposure of at least 44 countries to exceed 10% of their GDP, and using the loan to challenge the state's sov there is only so much the rest of the world can do to help as the World Bank's Debtor Reporting System only tracks obligations made in the name of the public sector where the government holds 50% or more shares. If it is not by the government, the World Bank and other international organisations aren't involved in the equation, letting the creditor be free to exercise their

leverage without any upper check. This ends up creating what we call a debt-trap diplomacy. Several analysts claim that China is

ereignty and imposes multiple unfair trade and financial deals with poor countries that are in need of the money.

BRI, which was supposed to deliver infrastructure to countries in Asia, Africa, and Europe, is now being considered as a massive debt trap, given that only 3% of it is pure aid and rest comprise financial loans.

But all of this is on paper. Has any country actually suffered ?

■ The biggest shining example of repercussions of BRI contracts and confidentiality clauses that come with it is Sri Lanka. The country had to cough up the Hambantota Port and 15,000 acres of surrounding land for 99 years as payment when it failed to repay a loan in 2018. The government stated that the intelligence and strategic opportunities of the port were also a part of the deal. This implies a direct security implication for India.

Tonga, who sought a loan from China, and failed to repay it in 2013-14, and the loans ended up claiming 44% of Tonga's GDP.

■ The Maldives, too, stands at risk as 1.4 billion USD, approximately 78% of the country's external debt, is only owed to China.

■ As per the same report by IFFRAS, the Chinese BRI contract with Montenegro entails clauses where the inabil-

■ Another example is that of ity to repay the money will give the Chinese government the right to access Montenegrin land as collateral. Also, the contract states that any legal dispute would be placed under an arbitration court in China. Currently, Montenegrin debt stands at 65.9% of its entire GDP, China being 25% of it.

> ■ India will also need to be on their toes as most of its neighbours have fallen prey, including Pakistan.



to pay up, China is said to use the upper-hand to support their geostrategic interests. A recent report by International Forum For Right And Security (IFFRAS) revealed that most BRI contracts entail several confidentiality clauses. One of them is that the contracts for these infrastructure projects will be given only to Chinese state-owned or state-linked companies that charge higher prices than the open market.

Around 80% of these contracts also contain a No Paris Club clause. The Paris Club is an infor-

Many of these clauses give the lender, in this case China, the ability to cancel loans or reschedule payment at will, increasing their control.

As per IFFRAS, the contracts stress on keeping the terms of credit secret from the World Bank, other international agencies, and even citizens of both the countries involved.

These clauses and terms of repayment will curtail the crisis management and renegotiation options for debtors. All of this put together points to a detailed strategy on China's part.

So, what will happen now?

A large number of the BRI loans have the period for repayment starting from 2021 onwards, meaning that the coming years will see China capitalising on other countries' fiscal mismanagement. A lot of negotiations can be assessed to be on equity swaps rather than on alleviating debt and helping other countries, meaning more and more power for China.

A ray of hope is that the

pace of lending on BRI has slowed down in the past two years. Several countries on the Chinese credit list are witnessing more pushback against the BRI.

The USA has also led a G7 effort to counter Beijing's dominance in international development finance in collaboration with other countries like France, Canada, Germany, Italy, Japan, and UK. Termed as the Build

Back Better World (B3W) initiative, it aims at offering 40 trillion USD in investment in developing countries.

Australia has also backed out of its BRI contracts, with many other countries following suit. This has weakened BRI's further reach. In addition, the country has also introduced its 2 billion USD Australian Infrastructure Facility for the Pacific (AIFFP) as a counter to BRI.

A Timeline Of How India Changed A Moment Of Crisis Into One Of Opportunity

The crisis (1947-1991)

Economy In Flux

Having freed itself from British Raj in 1947, India took up the cause of socialism under the then PM Jawaharlal Nehru. For government intervention was seen as a way to upgrade the Indian economy that had been left impoverished by the capitalistic British rule.

As a consequence, License Raj or Permit Raj (1947-1990), system of a regulations and licenses was established. This impeded the establishment and running of businesses, for it required private companies to seek consent from about 80 or above government agencies to begin prowhich duction, was regulated further.

This form of centralised planning, along with a draconian set of economic controls on foreign trade, production prices, and capital flows, needless to say, led to economic stagnation. Indian economy, from 1950s to late 1980s, "grew" at an average rate of only 3.6%, with per capita income growth averaging at 1.3%.

Two wars (Indo-

needed monetary aid to survive, so the Indian government approached the IMF and World bank. In return, India was asked to open up its economy, lower tariffs and devalue the rupee to boost exports. An attempt was made to achieve these, but the internal political backlash forced the government to stick to its original restrictive methods.

It was now clear that India lagged a lot behind its East and Southeast Asian neighbours. As a result, the governments of Indira Gandhi and subsequently Rajiv Gandhi began pursuing economic liberalisation in the 1980s by relaxing trade-related constraints. These reforms lead to a momentary increase in the average GDP growth rate in the 1970s from 2.9% to 5.6%.

Alas, the Indian political scene began to implode in the late 1980s. The Bofors scandal, IPKF misadventure, Shah Bano case, etc., all smeared the image of Rajiv Gandhi's government, hindering all the liberalisation efforts, and distressing the Indian economy further.



storm, the Balance of Payments crisis. The country was importing more than it was exporting, for our primary buyer, the Soviet Union, was now in turmoil and ended up dissolving in 1991. This trade deficit was further exacerbated by the Gulf War (1990–1991) that caused the price of crude oil to skyrocket. As a result, India's foreign exchange reserves depleted (1 billion USD by January 1991) to the point that the country could barely finance two weeks' worth of imports.

Not to mention, the government expenditure was more than the total earnings, owing to which the fiscal deficit peaked, too; it rose from 9% in 1980-81 to 12.7% in 1990-91. The internal debt also rose, from 35% in 1985 to 53% in 1990-91.

India finally had to go to the IMF and the World Bank to ask for assistance, which promptly asked India to pledge 20 tonnes of gold to the Union Bank of Switzerland and around 47 tonnes to the Bank of England and Bank of Japan in return for an emergency loan of about 2.2 billion USD

As the news about the bailout deal spread, it resulted in a huge public outcry. This led to the fall of the then Chandra Shekhar led government, with PV Narasimha Rao taking over as the new Prime Minister of India and Manmohan Singh as the Finance Minister in June 1991. What followed next was what we call the liberalisation of India.

On July 3, 1991, the RBI devaluated the Indian rupee by 9% and a subsequent 11% with respect to the USD, in an attempt to make exports cheaper and accordingly, stock up the depleted forex reserves once again.

License Raj was abolished, loosening import restricand further tions scrapping production licensing. The industries were now free to decide what to produce and in



USD in 1991-1992 to 5.3 billion USD in 1995-1996.

Bank interest rates were liberalised, allowing market forces to dictate them instead of the government. The statutory liquidity ratio and cash reserve ratio were also significantly reduced, from 38.5% and 15% respectively to 25% and 10% respectively.

The government also started selling some of its public sector companies to the private sector, bringing in more cash and also, at the same time, dismantling public monopolies.

Owing to these pathbreaking liberalising reforms and the subsequent adjustments, the GDP of India managed to rise from a meagre 266 billion USD in 1991 to around 3 trillion USD in 2019. Though liberalisation and economic reforms still have a long way to go, one cannot simply overlook the impact they had back then and still continue to have on the Indian economy!
