

The great housing

dertainly, there's no gain saying that our homes status symbol for some, necessity for others - shelter us from all sorts of storms. But unfortunately, the same cannot be said for the housing market. Knee deep in a supply and demand quandary, the market finds itself caught in the eye of the storm. Stick around as we try and delve deeper into the issue.

The storm at hand

The world is currently reeling under an acute housing deficit. USA alone, for instance, requires some 6.8 million homes more. With 350,980 properties up for sale in 2021, 36% fewer than at the start of 2020, UK too doesn't fall far behind on the housing shortage index.

"Why the dearth," you ask? Blame it on contemporary capitalism, we say! With a superfluity of luxury housing and a lack of affordable housing, the market is catering to the greed of homebuilders and realtors, and not to the need of common populace. And if this wasn't enough, COVID-19 induced shortage of building materials and labour. According to the data available, as much as 30% of the building material comes from China and many companies source stone and glass from Italy; since these two nations were some of the hardest hit early on in the pandemic, the situation led to delays in supply chains for countries that relied on them.

To make matters worse, this dearth of available housing collided with a rush of buyers looking for more space. Fuelled by

historically low interest rates, the pandemic-triggered shift to working from home, housing demand is currently at its peak. Indian Analytics company CRISIL reported a dramatic rise of 33-38% in housing demand in the last fiscal year. All of this combined has sent the house prices in every corner of the world skyrocketing, even surpassing incomes in majority of them. In the last half of 2020 as well as the first half of 2021, the property prices in US rose by 11%; the fastest in the last 15 years, with the average price of a house nearing one million USD in

about 200 US cities. In New

for a house there averaged 20.8 times the annual household income. Indian markets, on the other hand, are still projecting a potential 6-10% increase in residential real-estate prices across top six cities this fiscal year. All in all, dreams of owning a house seems to be going up in smoke

Efforts made to ward it off Politicians across the globe are brainstorming on ideas ranging from rent caps to special taxes on landlords, from nationalising private property to increasing interest rates, in order to resolve the crisis at hand. In 2021, Asia's largest economy, China, stepped up restrictions on the real estate sector, as the cost of an apartment in Shenzhen got as far as 43.5 times a resident's average

salary. In the US, the government increased mortgage rates to balance supply and demand which reduced the new house listings by 0.9% in April 2022.

Much before, Australian Prime Minister Scott Morrison's conservative government announced a 'comprehensive housing affordability plan' worth 728 million USD as part of its budget to boost supply, Sinn Fein in Ireland proposed building 100,000 social and affordhomes, and reintroduction of a pandemic ban on evictions and rent increases, along with a legislation to limit the rate that the banks can charge for mortgages.

In the case of India, a cheaper construction material has been found - glass fibre reinforced gypsum (GFRG) panels which use a minimal amount of concrete and steel - reducing the cost of raw material. It is believed that these houses will be more affordable. To note, these are just a few problem-solving measures that are being undertaken around the globe, but would these be enough? We think not. For, if projections are to be trusted, housing prices would still move up 10.8% in 2022. However, experts still believe that we are not in a bubble and fortunately nowhere near the 2007-08 period of great recession. Fingers crossed!

It's Time To Destigmatise The Taboos Around Mental Health Issues

eet Shalmali Jadhav, founder, Empathy For You, a social institution that works towards apprising people on mental health and suicide prevention. Also dubbed as the youngest member at UN's In-

ternational Youth Council, she is making great strides as a fervent changemaker by making a positive impact on the world. For her endeavours, she got featured in numerous newspapers, and social networking platforms. We present to you excerpts from her recent interaction with us...

The inception

When I was in school, one of my close friends went into deep depression. In order to help her, I began researching and discov-Shalmali Jadhav, founder, Empathy For You ered the stigma and taboo

around mental health. I also realised that she might not be the only person suffering from the same. These issues coupled together subsequently and ignited the spark within me to come forward and help. And that's how Empathy For You was born, where we, a small group of mental health advocates, work together to destigmatise mental wellbeing. During the pandemic, we came up with a campaign, namely 'Dear Superheroes', under which we sent some 400 thank you letters to the frontline workers. This might sound a little outdated to some, but I believe that letters give a personal touch to a simple text and create more impact. Because in the end, it is all about letting them know that they are not alone.

The key challenge

Even though mental health is an important aspect of an individual's life, funding remains to be a major challenge. Though a lot of awareness was raised on the issue during the lockdown period, the backing provided was still insufficient. As a result, we were unable to carry out a lot of campaigns that we thought would significantly impact our current standing on the issue. Dealing with the lack of resources has been a major struggle for me since the very beginning, and it continues to be till now.

The approach

On an autonomous level, reading books, playing videogames, etc., are some great ways to deal with mental stress. In fact, believe me when I say this, even scrolling through Instagram pages can be helpful for some. But just make sure you don't overdo it. Along with this, physical exercise such as yoga is important too and should be made an integral part of our lives. On a more legislative level, introducing Socio-Emotional Learning classes in schools, wherein kids get to learn how to come to terms with their emotions or feelings at an early age, would aid a great deal too. This is necessary because we live in a society that often asks us to conceal our emotions despite being well-aware of the fact that it isn't a healthy practice to inculcate.

Eases visa ban for Indian students

With the new visa rules having already taken effect from August 24, 2022, over 23,000 Indian students who were stuck back home due to COVID visa restrictions would now get a chance to resume their studies.

This represents a substantial departure from the 70-year-old Miss Universe tradition, wherein only single, childless women between the age of 18 and 28 were allowed to compete.





Demands PM's resignation

Thousands of Haitians took to streets in Port-au-Prince, the country's capital, on August 22, demanding PM Ariel Henry's ouster over rising inflation and security concerns in the nation. Suffering from political instability and a rise in gang violence, intensified by President Moise's murder in July 2021, the citizens long for a better quality of life and want the PM to resign.



The nation introduced Bharat Biotech International Limited's oral vaccine, Rotavac for the immunisation of children from the deadly diarrhoeal disease Rotavirus. Out of 5,25,000 underfive, diarrhoeal illnesses related deaths globally each year, Rotavirus is responsible for roughly 2,15,000, over 50,000 in Nigeria alone, making it the most common cause of severe diarrhoea.

Transferable Skills, The Key To Have A Great Career

Interviewer: So, apart from your educational degrees, what skills do you have for this job profile? Interviewee: Sir, I have acquired a set of transferable skills from my last two jobs, which would help me implement my acquired knowledge in a much more impactful manner.

Interviewer: Well, that's impressive, and I feel that's what makes you different from just a candidate with degrees and certificates. You are selected.

Having watched the foregoing conversation being relayed in a YouTube ad, I kept my phone aside and wondered what these skills are? "So impactful that it could convince these interviewers even more than the degrees?" I thought out loud. As such, intrigued enough to quench the number of questions brewing up in my head, I delved deeper into the world of transferable skills. Here's what I managed to get my hands on...

What are transferable skills?

Preferably known as 'portable skills', transferable skills are a set of skills or abilities that one develops from working in an organisation and carries from one job to another. In fact, these are the skills that are relevant across different areas of life, be it scholastic, social, or professional. Though your academic skills or



your technical skills do provide you the base to get your work started, it is the transferable skills, roughly including your ability to solve problems, handle a team, and so on, that take the credit for you to work efficiently and let you utilise your acquired knowledge to its optimum.

What are the different types of transferable skills?

As per professional career planner Rosenberg McKay, these fall in six broad categories. The basic skills that are essential to survive in the professional world fall under the first category. The ability to communicate with your team and carry out basic written communication. Next in line, we have the ability to create a friendly and positive office culture, and the ability to build excellent relationships. Management or the ability to manage and balance the work and train any new employee comes in a close third. Fourth is having clerical expertise in using programs; this skill is required in almost every job at a certain level. Fifth is research and planning; that is the major skills that one must instill in order to understand what work to prioritise when a list of work gets placed on your table. Last but not the least is the basic knowledge of computers and technology to keep up with the new technology.

Are these different for different job profiles?

The simple answer to this question is no. For when an individual works for decades in same field,

they are likely to develop a set of professional skills which are not job-specific and apply to every job. An essential element of your career tool belt, these skills, unlike the knowledge you gain at your school or college, keep increasing with every new experience you gain.

How to identify one's transferable skills?

As per a survey conducted by LiveCareer, 20.8 million people find it hard to capture their transferable skills, with an additional 19.3 million struggling to provide reasons as to how their skills would apply to another job. When such is the predicament, the need to find a working solution becomes imperative. Experts suggest ways like focusing on the real work instead of one's title, letting go off the industry one's working for in lieu of a new one, tightening your grasp on soft skills like teamwork instead of hard skills like inventory management, etc.

All in all, it is important for this generation to realise that just being educated is not sufficient to reach heights. Parallel to acquiring theoretical knowledge, one must keep developing these skills to prove to be an asset to the organisation one's working with. Since the pandemic has erased so many industries, leaving millions of people behind, reinvention is the key. And only transferable skills can help one take this leap.


Book: Rogue Lawyer **Author:** John Grisham Published in: 2015 Genre: Legal thriller,





Based on similar methodologies, 'AIR in Healthcare' has been designed to help in the early diagnosis of a user's health conditions by integrating

All reports will then be stored as cloud information in Alexa. After each week, the user can get a predicted data, according to the artificial intelligence algorithm, installed in the system, health. AI will also provide the users with a detailed information about their chances of getting a particular disease in the coming future based on their current health conditions, and this in turn will help users to take the necessary precautions. According to Akshat, the mantra behind this AI robot is the age-old wisdom of 'Prevention is better than cure'. The accuracy rate of the results predicted by the AI robot has turned out to be as high as 80%. Decoding The Underlying Rationale Behind Filing A PIL

Misuse of Pl

ebasing the appellation 'Public Interest Litigation' and what it propounds, sundry frivolous litigations are filed in the courts of law every other day in the name of common good. The underlying rationale? We seek to deduce!

What?

For the unversed, PIL, in consonance with the principle of 'Justice for all' espoused by Article 39A of the Indian Constitution, is a litigation filed to secure public interest. It aims to extend the long arm of the law to those underprivileged and uninformed, whose rights are infringed and whose grievances go unheeded, unrepresented and unheard otherwise. Introduced by the 17th Chief Justice of India, PN Bhagwati, in 1980, this rule of law sanctions third party individuals the right to approach the law courts for justice on behalf of those who cannot. Into the bargain, the precise methodology to lodge a PIL is unexacting, involving no heavy court fees as opposed to the usual legal suits. Many a times, letters/post-cards petitioned to the court too have been conceded as PILs.

Why?

Bona fide PILs have proven to be utilitarian many a time and oft.

Case in point: MC Mehta v. Union of India
Seeking closure and relocation of Bharat Heavy
Electricals Limited, Bhadrabad, Haridwar, and the
likes for discharging hazardous industrial effluents
into the Ganges, M C Mehta, a social activist lawyer
filed a PIL with the Supreme Court of India in 1985.
Following which, the apex court issued orders to relocate numerous polluting industries on the banks
of Ganges and passed several landmark judgements,
predominantly resulting in the formation and implementation of the Ganga Action Plan (1985).

Why not?

Howbeit, instances of their abuse are aplenty, defeating the very concept of a PIL. Under the facade

of public good, people are found to serve their own personal interest.

Case in point: Kalyaneshwari v. Union of India Gujarat High Court received a writ petition in 2011 that sought the shuttering of asbestos units, claiming the material to be deleterious for humans. However, the court later deduced that the litigation was filed by rival business groups who aimed to sponsor their own products as viable substitutes for asbestos, and disposed of the petition, citing private gain as the ulterior motive behind it all.

Settle political scores

Case in point: Chhattisgarhi Samaj party v. State of Chhattisgarh

Chhattisgarhi Samaj Party, a registered political party, lodged a petition against the then state government in 2017 seeking CBI investigation in the 2015 incident when a dais constructed for the PM to address a rally in New Raipur fell due to bad weather, purporting for it to be built using adulterated material. The court dismissed the plea as one filed by a political party to gain mileage, that too, two years after the incident in question. The party

moved the apex court for the same, only to be slapped with a fine of one lakh INR.

And seek publicity

Case in point: Rakesh v. Union of India
Rakesh, a resident of Delhi and a social worker,
filed a petition in the Delhi High Court in 2021 to
seek dismissal of Amitabh Bachchan's voice from
the caller tune on COVID-19 precautions. The
grounds were that Mr Bachchan himself, along with
some of his family members, could not evade the
malady, nor is he an almsgiver, questioning the need
for the Government to then shell out for his voice.
The petition, however, became infructuous as the
caller tune was by then already removed.

Such dubious petitions not only waste the time and resources of the court which could have been utilised for the disposal of genuine cases, but also create a huge backlog of pending suits, also violating Article 21 of the Indian Constitution that promulgates our right to speedy trial.

We yearn for justice when we are the ones being unjust to it. Such is the travesty of justice!

Water for all



Goa is known as the ultimate holiday destination. Recently, however, the state earned yet another distinction, that of being India's first 'Har Ghar Jal' certified state under the Jal Jeevan Mission program of the Indian government. This

means that all the households in the villages of Goa have access to safe drinking water through taps. While reading this news, I was transported back to the time when my parents had relocated to our native village, with an aim to encourage education among villagers. At that time, there was no tap in any house and the entire village depended on a handpump, or chaapakal as it was called colloquially, for its water supply. While the water drawn from handpumps was cool and clean, a lot of water was wasted due to spillage. Noticing this, my mother's first initiative was to install a tap in our home, and taking inspiration from this, many more households followed suit. This is where education came in. Installing taps was just the first step, villagers had to be trained to close the taps, not leave it open while doing chores, and most importantly, cleaning the pipes and tanks regularly. The reality of rural India hasn't changed much since then, and the next challenge is going to be the same for other villages as well. Villagers will have to be taught the importance of water conservation and sanitation to fully realise the vision behind Har Ghar Jal. However, the change is already happening in urban spaces, and especially among school children. One example is of Amity winning the Best School Award recently at the Annual Water Awards Contest. Indeed, the dream of every Indian household having access to potable water is no longer a distant one. GT

Measures that can be undertaken

Even though different countries are working their fingers to the bone to address the issue, the globe calls for more sustainable and well-planned solutions. One such measure can be adopting the policy of 'upzoning'. This involves the governments at the local level to reclassify single family areas in order to allow the construction of taller and denser buildings with several units per lot. A few local governments in Berlin and Germany are already adopting this policy, however, this initiative is faced with lack of scale as one of its major downsides at present. More mortgages for home buyers can be an-

other solution. Although, for potential homebuyers, down payment assistance programs already exist, it often becomes hard to obtain when it comes to bidding for a property. Relaxing and loosening banking regulations thus might allow smaller down payments which can ease the burden on buyers and help ensure that home ownership is more attainable for the middle class.

The bottom line is that *makaan*, just like *roti* and *kapda*, once again needs to be seen as a basic human right, a necessity and not a luxury, so that the housing needs of the growing populace can be met and a certain standard of living can be attained for all, be it the poor or the rich.

in an annoyed tone.




Tribute to war heroes

The MISSING princess story



uring the Bolshevik Revolution, the Romanov family, the last imperial dynasty to rule Russia, vas killed after over 100 years of rule over the land. The event was tragic and unfortunate, but it soon turned mysterious when the dead body of the princess of the family, Anastasia Romanov, was nowhere to be found. And so the ball was set rolling for one of the biggest mysteries in the world.

Who was Anastasia Romanov?

The very famous and mysterious young lady, Anastasia Romanov, was born in Petrodvorets, Russia, on June 18, 1901. She was the daughter of Princess Alix of Hesse-Darmstadt and Russia's final tsar, Nicholas II, Nicholas II, Anastasia's father, was the part of Romanov dynasty that ruled the country for three centuries. The royal couple had three daughters and an elder son, Alexei, who was supposedly the heir to the throne. Anastasia, on the other hand, spent her early life decently with all the basic education being provided to her, along with learning everything that was deemed necessary for a princess, until her entire family was killed in 1918.

What happened on the doomsday?

Although the date of the execution is said to be either 16th or 17th July, 1918, most of the sources confirm the latter. The family was taken to the Ural mountains and was placed under house arrest. group of executioners suddenly opened fire on them, silencing the whole Romanov legacy in that basement forever.

What arose the missing mystery?

Even several years after the ill-fated incident, the speculations didn't die down. Many claimed that princess Anastasia and her brother survived due to their family jewels being sewn on the cloths that may have acted as a shield. The rumours grew when a woman was admitted in a hospital and doctors claimed that she had suffered such traumatic events that she could not even remember her own name. It was because of her accent that doctors could comprehend that she was Russian. A few days later, another Russian woman was admitted in the same hospital and claimed that the first woman was the long-lost Princess Anastasia. There was no proof, but when have rumours needed proof?

What is the truth then?

Well, there are, obviously, two renditions of the story: one genuine, one fantasy. There were various young women who came up to claim themselves to be Princess Anastasia after that. Out of them, the most famous claimant was a woman who named herself Anna Anderson but was actually Franziska Schanzkowska, a Polish woman married to an American professor named J.E. Manahan. In 1970, archaeologists found a grave containing skeletons of six adults and three children. The continuous investigation identified the nine bodies to belong to the Romanov family, but the bodies of Anastasia and her brother were still missing. It was finally in 2007 that a new DNA analysis from another grave identified Anastasia and Alexei, putting an end to the 90-year-old mystery.
